Treasurer's Report for 2023

The books and records are complete and accurate. The Federal and California State tax returns have been timely filed for all years through 2022 and will be timely filed for 2023.

At the end of 2023, District 22 had a net worth (Net Fund Balance) of \$239,340. This included cash held in checking accounts of \$253,041, other prepaid expenses of \$455, hotel deposits of \$5,000 and net fixed assets of \$8,254. Total current liabilities of \$27,410, included a payable of \$21,456 to the Westin Rancho Mirage for the 2023 Palm Springs Regional, and our contingent liability of \$5,904, which are funds earmarked for a potential NABC Tournament.

In 2013, the district's board of directors began investing in our own tournament supplies. District 22 is a party to a contract with an individual to manage these supplies.

District 22 had a net profit for 2023 of \$53,315 compared to a net loss of \$21,986 for 2022. Our net profit for 2023 increased by \$75,301 compared to 2022. The increase in profit was due primarily to the return to profitability of the three Regional Tournaments District 22 ran in 2023. Our Palm Springs Regional generated a profit of \$51,524, the San Diego Regional showed a profit of \$8,943, and the Ventura Regional ran a profit of \$7,307. The profits from these tournaments were slightly reduced by a loss of \$1,301 from District 22's NAPs and a loss of \$1,115 from District 22's GNTs.
